

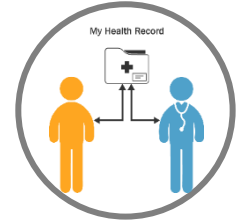

How to add allergy information into My Health Record: A guide for consumers



Why add allergy information

My Health Record is a way to share information about your serious allergies with doctors and other healthcare providers in an emergency or if you, or your child, go to hospital.

It may be useful in other situations, including travelling within Australia or visiting a different clinic or specialist.

Your information in My Health Record is available wherever you go.

In an emergency, your treating healthcare providers will be able to access a summary of your allergies. This includes allergy information you have added, as well as allergy information that your healthcare providers have added.

It is strongly recommended that you add information about serious and life-threatening allergies including:

- drug (medication) allergies
- food allergy
- food protein induced enterocolitis syndrome (FPIES)
- allergies to substances that you might be exposed to in hospital (e.g. latex)
- other serious allergies (e.g. bee, wasp or tick anaphylaxis).

In an emergency, this information is essential for doctors to know.

What should be entered

The National Allergy Strategy recommends that you **add medically confirmed information about any serious and life-threatening allergies.**

It is a good idea to talk to your doctor or clinical immunology/allergy specialist about what information to add.

You should have an Australasian Society of Clinical Immunology and Allergy (ASCI) [Action Plan](#) for those allergies.

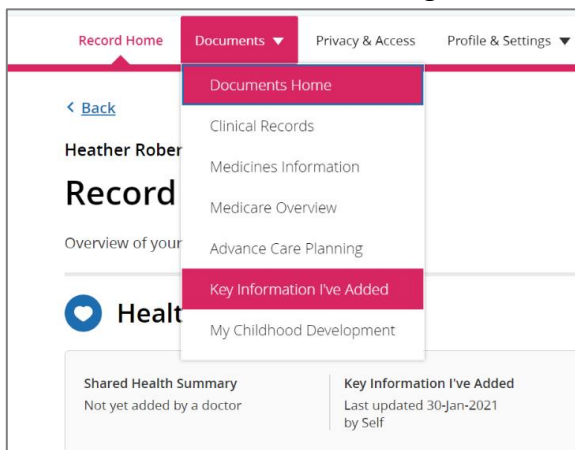
When you add an allergy into My Health Record, you will need to add the:

- **name of the substance** you are allergic to (e.g. name of the drug, food or insect)
- **type of reaction or symptom** you experienced (e.g. hives, itching, vomiting, anaphylaxis).

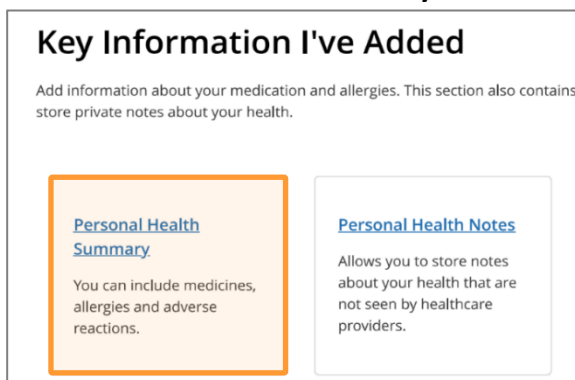
You should include any allergy information that is important for your healthcare providers to know about, especially food and drug allergies or other serious allergies (e.g. latex allergy).

How to add allergy information

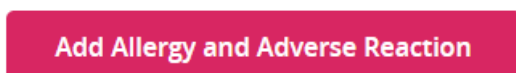
1. Complete the steps to sign in to myGov and link the My Health Record service. 2. Select **Documents** from the navigation bar. Then select **Key Information I've Added**.



3. Select **Personal Health Summary**.



4. Under the Allergies and Adverse Reactions section, select the **Add Allergy and Adverse Reaction** button.



5. Add the **Substance or Agent** you are allergic to. Then add the **Adverse Reaction** for each substance. The 'Substance or Agent' should be **specific and accurately** stated.
 - **Do** specify the name of actual foods that you are allergic to, **instead of** the food group. For example, add *cashew*, *walnut* or *peanut* instead of *nuts* or *tree nuts*, which is less specific (unless you really are allergic to all tree nuts).

- **Do** use the name of the drug you are specifically allergic to (if known), **instead of** the group of drugs. For example, add *amoxicillin*, *augmentin* or *benzylpenicillin* instead of *penicillin*. Add *Bactrim* or *sulfamethoxazole/trimethoprim* instead of *sulfur* drugs.

The **Adverse Reaction** should be simply and accurately stated, so that if the reaction is severe, it can be clearly seen. Some examples of reaction types include anaphylaxis, severe rash, and severe vomiting.

Adding an adverse reaction is optional but doing so will enable a healthcare provider to see how serious the risk of exposure to the substance or agent is to your (or your child's) health.

More than one reaction can be added for each allergen or substance. You can also add more than one allergy.

6. Select **Save** once you have added your allergy information.

1. Select **Record home** from the navigation bar.
2. Under the **Health Snapshot** section, select **Allergies & Adverse Reactions and Medicines Information**.

3. Under the **Allergies & Adverse Reactions** select **Expand** to view all listed allergies.

How to update allergy information

You should keep your allergy information up to date in My Health Record throughout your (or your child's) life, since the allergy information may change.

- You may have been told you are allergic to amoxicillin, but:
 - you have been tested and passed a challenge for amoxicillin; or
 - you have been given amoxicillin and did not react, and a doctor has now confirmed that you are no longer allergic to amoxicillin.
- Your child may have been allergic to a food (e.g. egg) as a young child but has since grown out of the allergy and passed a food challenge.

It is important to **update your allergy information** if you are no longer allergic to something or if you develop a new allergy.

To remove or make changes to an allergy you have entered, click under 'Actions'

If it has been confirmed that you (or your child) are no longer allergic to something, the National Allergy Strategy recommends that you write 'Confirmed NOT ALLERGIC' rather than remove the allergy. Read through the amoxicillin allergy example below:

1. In the **Substance or Agent** field, add 'amoxicillin'.
2. In the **Adverse Reactions** field, add 'confirmed NOT ALLERGIC. Passed challenge (add date) and (add name of specialist).
3. Click **Save** once you have finished updating the information.

Using this wording will help healthcare providers understand your reactions clearly.

Talk to your doctor about uploading a shared health summary

A shared health summary represents a person's health status at a point in time.

If your (or your child's) allergies change, you can ask your doctor to update their practice records and upload a new shared health summary with the correct allergy information to your (or your child's) My Health Record. Your doctor can remove a previously uploaded shared health summary that contains out of date allergy information.
